## 2023 Sponsorship Levels

There are two types of sponsors (**Team and League**) with different sponsorship levels within each type.

### **Single Plan (\$50 donation)**

### **Double Plan (\$100 donation)**

### **Triple Plan (\$250 donation)**

### **Home Run Plan (\$500 donation)**

- Individual Banner with your company name/logo along first or third baseline at the Echo Mountain Field

The **League Sponsorship** type is for companies or individuals that provide donations to the league that are not directly associated with a team, and can be in the form of monetary donations or services.

**Section IV – Sponsorship Agreement**

Sponsorship of a team in DBLL does not permit the Sponsor to have any rights or responsibilities in the operation of DBLL or any team in DBLL, nor does the Sponsor have any rights or responsibilities in the selection of manager, coaches, or players for any team in DBLL. Nothing herein shall make us partners or joint ventures. The Sponsor and DBLL are independent contractors with respect to one another, and neither shall have any authority to represent or bind the other in any manner or to any extent whatsoever, except as specified herein. The Sponsor shall have the right to use the following term in advertisement, posters, brochures, newsletter, etc.: “Sponsor of a team in Diamondback Little League.” Sponsorship does NOT give the Sponsor the right to use the word “official” in connection with its Sponsorship. Any reference to the Sponsorship under this agreement must make it clear that the Sponsorship is with a team or teams in DBLL only, and NOT for Little League Baseball, Inc. Use of the “keystone logo” or any other logo of Little League Baseball, Inc. is prohibited, unless Little League Baseball International expressly grants permission in writing.
