

#### INDEPENDENT CONTRACTOR AGREEMENT

Referee Development Program

This independent contractor agreement is to be signed and submitted to Kristine Marohl, WVSRA treasurer, for processing. By signing this independent contractor agreement, both parties understand and agree that this document is in no way a binding agreement between the Referee and the Wenatchee Valley Soccer Referee Association, but rather a mutually agreed request for independent contractor payments per games officiated in the WVYSA. The WVSRA can nullify all or part of this independent contractor agreement by taking disciplinary actions against the independent contractor. By signing the Referee, (independent contractor), understands that he/she assumes all tax liability, whether State or Federal.

Please note, this independent contractor agreement must be typed or written in ink and legibly completed in its entirety. Otherwise, it will not be accepted and processed.

Compensation per game: U8 - \$15, U9/10 - \$20, U12 - \$25, U14 - \$30

If the Referee misses two assigned matches during any given season, the Referee will be fined \$10 for each game missed and be suspended from the Referee Development Program for the remainder of the current season. The Referee may be reinstated prior to the next season upon completion of an additional clinic.

### Game Assignments

We use ArbiterSports.com for our assigning software. All games will be listed on this site. You will receive an email, at the address we were given, inviting you to be apart of our group. Please accept and follow the link. You will need to log into Arbitersports to self-assign games and check your schedule. Occasionally we will notify you of a game that we need covered. Please either accept or decline the game within 2 days so we can make sure that the game is covered. To see available games- click on schedule / self-assign / enter

# Referee Attire/Equipment

Referees are required to wear their jersey, black mid-thigh shorts (no shorty shorts or yoga pants) and 2 or 3 stripe black knee-high socks. In cold weather you may wear a black under amour shirt or a sweatshirt under your jersey and black training pants. Gloves and a black soft bean hat may also be worn.

WVSRA provides a jersey, whistle and cards. The referee must obtain either a stopwatch or a watch with a countdown timer to keep game time. Using a cell phone is not acceptable

# Game Report

Referees shall complete and submit all game reports after each game in Arbiter. To be compensated for working your match, you must fill out a GAME REPORT. Once logged in, click on the Schedule tab. Check the "Show All" box in the date filter to see all games. Click the red **R** icon in the Notes column for the game for which you would like to complete the match report. On the match report please enter the score. Click Save/ Approved when you are finished.

### Season Compensation for RDP referees

U8 - \$15.00, U9/10 - \$20.00, U12 - \$25.00, U14 - \$30.00

On Arbiter you will see a different amount listed for game pay. This amount is for USSF certified referees. We encourage all of our RDP referees to get certified after trying out our program. Certification involves taking 4-6 hours of online class modules and attending an afternoon field training session. Cost is approximately \$135.00 for the initial clinic and then \$75.00 to renew each year. \$35.00 is reimbursable each season, if a youth referee officiates 5 rec games during the season.
