3. Boys Commissioners Report:

- Bill contacted Trophyworks in Carnegie to fix trophies, waiting for estimates
- Clean Up Rules Bill cleaned up the playing rules. Laura to consolidate the general rules and make one document going forward and will post on website
- Rules Committee Bill wants to set up a Rules Committee to review all current rules in place and see what needs changed/modified (i.e. little league vs bronco rules, etc)

- Youth Recognition Night for softball was May 5 not a very good response; will look to try it again next year

5. Old Business:

Bylaw Changes

New Bylaw provision for Tax Code needs put into bylaws – we read it last month and will vote tonight. WAS APPROVED BY ALL BOARD MEMBERS TONIGHT.

Upon the dissolution of the corporation or the organization, the Board of Directors or governing staff shall, after paying or making provision for the payment of all of the liabilities of the corporation or organization, dispose of all the assets of the corporation or organization in such manner, or to such organization(s) organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization(s) under section 501©(3) of the Internal

Revenue Code of 1954 (or corresponding provision of any future United States internal Revenue Law), as the Board of Directors or governing staff shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation or organization is then located, exclusively for such purposes as said Court shall determine, which are organized and operated exclusively for such purposes.

Read it this month and vote on it next month.

Section 8: All-Star selections: must make 75% of regularly scheduled in-house games up to the All Star voting date. Must also need to commit to availability for at least 2 out of 3 of the tournaments. Must be picked for in-house games not Travel league. The Spring Season's Summer All Star teams that were selected through the SFBSA All Star voting process will be the next year's Sunday League travel team. In order to participate in these Sunday League Travel Teams, those players must also play inhouse.

Consider adding another article after Player Eligibility (will firm up language but basic idea):

Article XV: Travel Leagues

The travel teams that were selected through the SFBSA All Star voting process will be governed by the SFBSA. The SFBSA will provide field time, insurance and supplies to those travel teams that were SFBSA All Stars the prior year and continue to play together through the next season and play in house. Any events hosted by the SFBSA will also be considered SFBSA sponsored tournaments.

All Star Committee Presentation

- Coach Pitch look to set up a tryout/combine/evaluation for the kids nominated at this level so
 that all of the coaches can get a chance to see all the kids at ages 7 and 8 before All Star voting.
 Coaches in another league or board members will run the evaluation so that all of the coaches
 at Coach Pitch level can see and discuss the kids. Coaches will still nominate kids for all stars.
- o Kid Pitch Coaches at this level have a little more experience seeing the kids. Coaches at 10A and B have been practicing together on Saturday mornings and have reached out to Kid Pitch coaches to ask those kids that they are considering nominating to participate in this joint practice as well. Also invited the coaches at that level to come down and watch so that everyone can see the kids in a practice setting running through drills/stations, etc. This is a pilot program right now. We have asked the coaches at 9A and B to consider doing the same thing. Kids will still get nominated based off of their in house play, but this gives another data point to get to review the kids that are nominated.
- Softball side will most likely remain the same, softball just doesn't have the number of teams
 that the baseball side does to facilitate the above processes however there was discussion on
 having the 8U softball players come down to the tryout/combine/evaluation day as well
- o There will be meetings scheduled with each of the coaches at each level to discuss the nomination process and how it will work. We will get this on the schedule as soon as possible.
- O Voting there will be at least one board member at each all star selection meeting and the commissioner of each side applicable (unrelated to any kids in the room at that level); the number of votes that each kid received will not be announced at the meeting; no voting information should be shared from those meetings all should be kept in the room. We will eliminate the nominations of A and B just nominate/vote for the best 22-24 kids at each level.

A team voting will then begin first – the unanimous votes will be automatically placed on the A team; those that were not unanimous will then be discussed (baseball skills) and revoted until the A team gets filled. The same process will follow for B team. There is still some work that needs to be done on the voting process so more details to follow.

- We will look to put together a uniformed email to parents that the coaches can send out prior to nominating a kid for both softball and baseball (including the commitment requirements, etc)
- Paul asked for a motion for the tryouts/combine/evaluation at the coach pitch level Bill V.
 motioned it was seconded and all board members present agreed.
- Paul asked for motion to remove the A/B designations when nominating Bill C motioned it was seconded and all board members present agreed
- Paul asked for motion for non-affiliated board member present and no votes to be revealed and board to attend vote and tally – Bill C motioned it was seconded and all board members present agreed
- Paul asked for motion for the prototype practices with 10 A/B and 9 A/B (and inviting those nominated) – Bill C motioned it was seconded and all present board members agreed
- Paul and board thanked Bill V and the committee for their work as they met at 3 separate occasions to discuss this proposal and present to the board.
- Coaches Clearances we are about 98% complete please get the remaining clearances into Laura as soon as possible.

We are going to let the contractors do their thing we know that A, E and Sturgeon are first on our list, but we will let the contractor work as they have planned.
- 2. Morgan E Batting Cage Project this will be placed on a temporary hold until the contractors are done with the fields. Coleman Mitchell will be donating items at cost to us, we have a net.
- 3. Shed Mark Hondru donated a shed to the SFBSA we are still considering the best place to put it more details to follow. We really appreciate the donation thank you!
