7. I will not be critical of teammates and never discuss teammate's abilities except to encourage good teamwork.
8. I will ensure my uniform and my other gear is complete, safe, and in good condition at all times.
9. I understand that I am on a team and will be a team player.
10. In any competitive aspect of my activity, I understand that winning is not always important. Doing my best at all times is important.
11. I will thank my teammates for their efforts.
12. I will listen to my coaches' instructions and show respect.
13. I know I represent the game of football either as a player or as a cheerleader. I further know that I represent my family, my team, and the Spencer County Youth Football Association.

Parent Code of Conduct

I recognize and accept my responsibility as a representative of the Spencer County Youth Football Association and my child's football/cheerleading team and pledge to follow this PARENT CODE OF CONDUCT:

- 1. I will NOT be a sideline coach or referee. I will limit my comments to positive reinforcement and encouragement to my child and his/her teammates.**
2. I will lead by example in exhibiting sportsmanship and fair play at every practice and game competition. I will encourage this behavior from other coaches, players, officials, parents and supporters.
3. I will place the emotional and physical well-being of my child ahead of a personal desire to win. Winning should be the result of preparation, hard work and discipline.
4. If my child develops a behavior-related problem that repeatedly disrupts practice and/or games, I will promise to work with my child's coach to resolve the problem.
5. I will do my very best to make football/cheerleading fun for my child and his/her teammates.
6. I promise to treat other fans, coaches, players, and officials with respect, regardless of race, sex, or ability, and I will expect to be treated the same in return.
7. I will not engage in physical or verbal confrontations with players, coaches, officials or fans before, during or after practices or game competitions.
8. I will refrain from the use of foul or offensive language.
9. I will provide encouragement to my child and teammates. I will refrain from making negative comments to my child or his/her teammates.
10. I will support the coaches and officials working with my son/daughter in order to encourage a positive and enjoyable experience for all.
11. I will be gracious in victory and dignified in defeat.
12. I will remember that the game is for my child and their teammates, not for adults.
13. I will remember that as a fan, I represent the Spencer County Youth Football Association. I understand that any concerns about officiating and/or coaching during a game must be directed to the Head Coach. I also understand that poor behavior during practices, games, may result in expulsion from the football complex, where I must wait next to my car in the parking area for my child. If this occurs, it may result in expulsion from the SCYFA.
