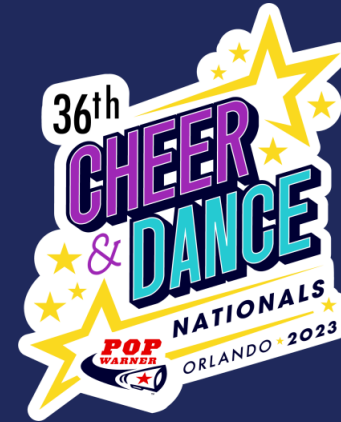

This manual will help in your trip planning to Orlando, FL & provide a more seamless experience throughout the booking process.

Please take the time to familiarize yourself with the enclosed information, as there have been numerous positive changes included for 2023 based on guest feedback from previous years:

- Included theme park pass to SeaWorld & Aquatica for up to 7 days
- Lower lead in pricing with choice of booking hotels WITH OR WITHOUT event transportation
- Wider range of hotel properties & spread out footprint
- Tiered pricing of hotels to fit any budget (quad occupancy) –
 - Budget priced \$99 - \$139 per night per room
 - Moderate priced \$140 - \$176 per night per room
 - Premium priced \$177+ per night per room
- 2 Pop Warner party nights - choose which one you prefer (first come, first served)
- Local add-on experiences – Universal Studios, dining, Orlando Magic, Fun Spot, etc.
- Two step booking process – 1st book your base package & 2nd secure your hotel rooms through a personalized link (once step 1 is complete)

Base Packages

All athletes and coaches of both football and cheer & dance teams must purchase this package and stay at pre-selected hotels for the duration of their trip.



Base Packages Overview

Congratulations on qualifying for the 2023 Pop Warner National Championship Week! Specially priced packages have been created for your trip to Orlando.

This year we are offering more hotel options, so you can find a hotel price point that works best for your team. Spectators can also take advantage of specially-priced packages offered by adding their names on the team's rooming list.

Bus transportation will be scheduled to SELECT hotels for those teams that require this service. If you require local bus transport, make sure to choose your "Bus Hub" hotel of choice.

Package booking has never been easier. Our new online booking system will expedite your registration process. No need to make a phone call to book your package, unless you would like extra assistance. The choice is yours!



Base Packages Overview

Package booking will be a two-step process this year:

- Step #1 – book your base package for all participants & coaches. Parents & other spectators traveling with the team can also be added.
- Step #2 – book your preferred hotel with or without transportation

In addition to a wide variety of tiered hotels, we are excited to offer additional theme park & add-on options enhance your stay in the Orlando area. These new options allow for increased flexibility in package bookings in an effort to keep your base package as low as possible, while giving you the opportunity to customize your group's experience. You are ultimately in control of your team's journey!

Start your fundraising efforts early in the fall to avoid the last minute stress of payment deadlines & being locked into specific pricing tiers! For mid to late November qualifiers, plan ahead in the event that lower priced hotel properties are already sold out. Carefully note payment deadlines, as there will not be any opportunity for late payments prior to rooms being dropped for other guests.

Base Package Components

Choose between two different base packages:

1. NO TRANSPORTATION BASE PACKAGE - the lowest priced option for teams that like to coordinate their own transportation needs.
2. TRANSPORTATION INCLUDED BASE PACKAGE – a slightly more expensive option that includes shuttle-style bus transportation to/from competition venues, SeaWorld theme parks & the SeaWorld party.

In addition, despite significant rate increases nationwide for labor & all associated expenses, the 2023 lowest base packages cost less than 2022:

All Base Package Included Components

- One (1) theme park admission Sports Pass per person valid for unlimited visits to SeaWorld and Aquatica (water park) for up to **7-consecutive days**. ***NEW FOR 2023**
- One (1) event admission ticket into competition venues for athletes, coaches & spectators booked within the package EVERY DAY between December 1-9, 2023 at both Camping World Stadium (football) & Orange County Convention Center North (cheer and dance).
 - *Event admission ticket is non-transferable and non-refundable; if lost, there will be a \$10 replacement fee.
- One (1) admission per person to the Pop Warner Celebration Party at SeaWorld, including all food, non-alcoholic beverages, shows & rides.
 - ***NEW FOR 2023** – PARTIES WILL BE HOSTED ON BOTH TUESDAY, DECEMBER 5TH & WEDNESDAY, DECEMBER 6TH – YOU WILL CHOOSE WHICH NIGHT YOUR TEAM WOULD LIKE TO ATTEND DURING THE BOOKING PROCESS, FIRST COME FIRST SERVED – CHANGING NIGHTS AFTER INITIAL BOOKING WILL NOT BE AVAILABLE
 - *Scheduled motor coach transportation will be available only to/from select “bus hub” hotels for those teams who have purchased this service for their specific night. Tickets are non-transferable and non-refundable.



All Base Package Included Components

- A three (3) night minimum length of stay is required. A full list of hotel properties can be referenced online and/or under the “Hotel Specifics” tab below. ***NEW FOR 2023 – wider selection of hotels with different pricing tiers:**
 - Football only – 24 properties available
 - Cheer and dance only – 47 properties available
- Scheduled motor coach transportation service will be provided ***NEW FOR 2023 – ONLY “BUS HUB” HOTELS WILL HAVE TRANSPORTATION INCLUDED.**
 - Football “BUS HUB” hotels to Camping World Stadium and/or Emery Hamilton Fairgrounds (practices only) scheduled during all competition hours Friday, December 1st – Saturday, December 9th .
 - Cheer and Dance “BUS HUB” hotels to Orange County Convention Center North Hall scheduled during all competition hours Sunday, December 3rd – Thursday, December 7th .
 - “BUS HUB” hotels to SeaWorld & Aquatica during park operating hours:
 - Football hotels – Friday, December 1st – Saturday, December 9th .
 - Cheer & dance hotels – Saturday December 2nd – Friday, December 8th .
 - “BUS HUB” hotels to the Pop Warner Celebration Party at SeaWorld between 7:00pm – 12:30am on both Tuesday, December 5th & Wednesday, December 6th.

Additional Base Package Notes

- Every room must have at least one (1) adult over the age of 21.
- Resort availability is first come first served.
- Standard rooms are a maximum of 4 people (including infants) – hotels with higher room capacities are noted in the descriptions.
- Package initial deposit is a minimum of 3 packages (~\$1500 depending on if you choose the base package with or without transportation). Deposit will be applied to the team contact booking the reservation.
- Airport transfers are not included in the package – reference the “Airport Transfers” page of the manual for options available.
- 1 unique email is required for each team.
- All athletes and coaches are required to sign & submit a waiver + code of conduct agreements online this season.
- If you have sister teams wanting to stay near each other, we recommend booking simultaneously.
- Tickets this year will not be mailed to teams prior to arrival. On-site ticket distribution locations & times will be communicated via the Official Website and Know Before You Go Emails the week prior to arrival.
- ***NEW FOR 2023** – new payment plan option allows multiple, pre-set dates leading up to the final deadline for payments to be scheduled.
- ***NEW FOR 2023** – just like most sporting events across the country, we are instituting a clear bag policy for spectators at both competition venues. A separate athlete/coach entry will be designated. Safety first, so plan accordingly!

Event Transportation & Bus Hubs

Need local transportation during your stay in Orlando?

Or are you already bringing your own bus or rental cars, so you don't need to rely on our scheduled buses?

We've got you covered either way!

During the online booking process, please take special note of which hotels have buses included. *NEW IN 2023 - to allow more flexibility in hotel property bookings, buses will run from pre-determined hotels that can accommodate large groups & reserved for those guests needing to use the service.

Bus Hub Hotels – Additional Notes

- Buses are not provided to any add-on activities, including theme park options to Universal, local restaurants, Orlando Magic, etc.
- Only participants booked at the “BUS HUB” HOTELS will be permitted & identified to use buses – guests at adjacent hotels will not be permitted to walk over to gain access to transports.
- Specific hours of operation will be posted on the Super Bowl website for reference during the event, along with QR codes located in the competition venues and at all bus stops.
- **NEW FOR 2023** - One shuttle bus will be dedicated to run between Camping World Stadium and Orange County Convention Center North Hall – specific pickup times will be finalized the week of the event (typically on the hour & half hour).

Hotels

Choose the option that fits your team's needs & budget. All rooms blocks & bookings are first come, first served.

We are holding an unprecedented number of local rooms December 1-9..... the highest ever for the national event. Size of room blocks vary widely by property, so we **HIGHLY RECOMMEND** you book rooms ASAP starting the Monday after your team qualifies. If your preferred hotel room block isn't available, you will be required to pick an alternate option.

In addition, we have been GUARANTEED the lowest hotel rates, so we encourage you to add your spectators onto your initial rooming block.

***NEW FOR 2023** – you will have the option to hold your room block for 2 days, at which point a one-night room deposit with tax will be due to secure your block.

Standard rooms are for a maximum of four people, while suites will accommodate five-six people (max. two kids per queen/king bed). *Children under two years of age are not charged for, BUT are included in the five-six people room limit. (1 heartbeat = 1 occupant)

Every room must have at least one (1) adult over the age of 21.

When booking your teams' rooms, take special note of the property descriptions as a majority of the hotels include free breakfasts. ***NEW FOR 2023**

For your convenience & planning, we have also listed any applicable resort and/or parking fees charged directly by the hotel, distance to/from competition venues & room descriptions with occupancy capacity.

Hotels – Additional Notes

- All hotels are located within 12 miles of the competition venues, with a vast majority within a 7 mile radius of Camping World Stadium (football) & 4 mile radius of the Orange County Convention Center (cheer & dance).
- “Bus hub” properties are reserved for teams requiring local transportation.
- Hotel rewards can now be earned with your stays, so take advantage – just input your number(s) during the booking process. ***NEW FOR 2023** Unfortunately, you cannot redeem any free stays in lieu of your package requirements.
- All taxes & credit card fees are included in the pricing. Any other parking fees, resort fees, complimentary breakfast, free theme park shuttles, etc. are noted in the hotel descriptions during the booking process (also denoted with # in manual).
- Rollaway bed additions are not an option.
- If there are any rooms needing ADA access, please make notes on your reservation during the booking process.
- If you are travelling with any sister teams & want to be blocked near each other, please includes notes on your reservation during the booking process. Blocks are not guaranteed, but will be taken into consideration by the property.
- Most hotels have convention space/meeting rooms available with catering requirements – sales contacts are included on pages 77-79 in this manual.
- Absolutely no cheer stunting in grass areas of hotels.

If any waivers are incomplete, the participant will run the risk of not being able to compete on-site and not receiving their welcome gift. Please ensure that your team is in compliance to avoid any disappointment upon arrival. (If an athlete and/or coach does not have an email, please use the head coaches' email.)

All waiver lists need to match your rooming list for the event, as an event credential for entry into competition venues will be given to each official participant upon book check at the start of the event.

Spectators do not need to sign waivers, but will be signing the code of conduct.

***NEW 2023** – the coach can manage who on the team has/hasn't completed their waivers online in their own team account. On the registration page, you can also find the waiver homepage under the header "Team Central".

***NEW FOR 2023** – all coaches, athletes, team administrators and spectators will be required to read and acknowledge a pledge to abide by the Code of Conduct of the Pop Warner organization.

GENERAL CODE OF CONDUCT

Pop Warner Little Scholars, Inc. is committed to cultivating a safe and welcoming environment for its regional and national events and programs that encourages and promotes good sportsmanship by student-athletes, parents, coaches, administrators and other spectators. We ask that event participants and attendees cooperate in being respectful at all practice and competition venues, partner hotels and/or ancillary venues throughout the course of the event. All those involved with the event are expected to refrain from the following behaviors:

1. Acting in a way that is unruly, disruptive or illegal in nature.
2. Intoxication or other signs of impairment that may potentially result in bad behavior.
3. Excessive use of profanities and other vulgar language that that interfere with other attendees' ability to enjoy the event.
4. Using bigoted, demeaning or abusive or other disruptive and intimidating language and/or gestures.
5. Verbal or physical harassment of officials, participants and coaches before, during and following the competition.
6. Disrupting the progress of competition (including physically entering or throwing objects onto the playing field or competition mat).
7. Interfering with or failing to abide by security or emergency procedures or response
8. Displaying signs that contain offensive language, or any graphic art that may be deemed disrespectful.
9. Defacing, destruction or theft of property associated with the event, including property of the opposing team or other participants, including officials, as well as official venues.
10. Violence or threats of violence against other individuals at any official venue.
11. Publicly criticizing or making derogatory statements of an official, opposing teams, event personnel or its policies, or other individuals associated with the event. This includes comments with respect to their conduct, character, competence, integrity or appearance. *Note: social media is deemed a public forum.*
12. Failing to follow instructions of event personnel.
13. Any behavior which otherwise violates conduct codes set by partner venues, hotels or ancillary venues including but not limited to theme parks, as enforced by those properties.

Failure to abide by these expectations are grounds for removal from competition. Pop Warner reserves the right to remove individuals or the entire team. Depending on the infraction, a one-year ban from Pop Warner events and programs will be considered. A repeat offense of the same infraction may result in a permanent ban. All removals will be without refund.

Rooming Lists

All athletes and coaches traveling to Orlando are required to be included on the official rooming list in your online account and purchase the event package.



Rooming Lists

All initial excel rooming lists are due no later than Wednesday after your regional qualifiers are completed:

- November 3-5 Qualifiers – due Wednesday, November 8th
- November 10-12 Qualifiers – due Wednesday, November 15th

Rooming list changes will be **accepted until 11:59pm EST on Monday, November 27th**. At this point, the system will be locked down, so our hotel partners can have all participant information ready in time for your team's arrival.

Any cancellations more than 72 hours from the start of championship week (prior to Wednesday, November 29th at 11:59pm EST), \$100 per room will be forfeited and all remaining money will be refunded.

For cancellations 72 hours or less from the start of championship week (Thursday, November 30th starting at 12:00am EST), no refunds will be issued.

In the event a football team loses early in championship week & wanted to depart prior to original checkout date, this will result in forfeiting any unused hotel room nights & package components (as the hotel cannot resell the room to other guests in a timely manner). No refunds will be issued.



Additional Competition Venue Spectator Tickets Available

Please include a signed copy of your league's [Roster Compliance Affidavit](#) in their place. Note: New for 2023, proof of scholastic fitness is only audited at the point of team certification; report cards are no longer audited at competition.

MUSIC VERIFICATION AREA: Immediately following Book Check, the Head Coach will proceed to a Music Preview Station to listen to and verify the team music. Music has been uploaded to this station following your Region Championships and/or Statement of Acceptance. After that time, there are no further changes to the routine music at Nationals with the exception of routine music that received a rules - Music Deduction (i.e., suggestive music or inappropriate for family viewing, etc.) at Region Championships. This type of Music Change (Music Deduction at Regions) must be submitted to National from the Region Coordinator no later than 5 business days following the Region event. There will be no music changes / submissions accepted on location.

WARM UP AREA: A Pop Warner volunteer will welcome your team and escort them to the Warm-Up Area.

The Head Coach will present the Team Book for Photo Identification Check for each athlete/rostered coach to enter the warm-up area, backstage and coaches' seating area.

Each Pop Warner athlete must have the Pop Warner Patch secured to the uniform in order to proceed. The Head Coach should also come prepared with a backup copy of the team music (CD/iPhone/iPad/iPod, etc.) even though it has been uploaded to the warm-up area and performance floor.

This station should take no more than 10 minutes. If discrepancies, the Region Cheer & Dance Coordinator will be on hand to resolve challenges with the Head Coach while the team and other rostered coaching staff will be permitted to keep with your scheduled warm-up time.

Once the Identification Check is complete, a Pop Warner volunteer will escort your team to one (1) of three designated mats (1, 2, 3) for warm-up, tumbling and stretching for a timed, 10 minute period (9 Minutes, 1 Minute to Exit Area).

The team will be asked to immediately move to one of three warm-up areas (1, 2, 3). A 54' x 42' surface will be provided (nine (9) panel matted surface) for a timed, 10 minute practice floor (9 Minutes, 1 Minute to Exit Area). The area will be equipped with a sound system (with uploaded music) for your warm-up time.

As soon as warm-up is complete, a Pop Warner volunteer will escort your team immediately backstage to the performance floor, entrance area.

PERFORMANCE FLOOR, ENTRANCE AREA: The team will move backstage (from the warm-up area) to the staging area. Members can leave team bags backstage in a designated area until your performance time is complete. The rostered coaches will be permitted to stay with the team until they are directed to the *Rostered Coaches' Area* on the main floor. When it is time to enter the performance floor, the emcee will announce your team to the floor as listed in the Statement of Acceptance. The athletes will enter the raised Performance Floor by ramp access, directly behind the performance floor, athlete stage right.

ARTICLES OF COMPLIANCE

POP WARNER CHEER AND DANCE NATIONALS

PERFORMANCE FLOOR, COACHES' VIEWING AREA: There is a designated area for the Rostered Coaching Staff on the main floor while your team performs. Coaches will enter the Performance Floor stage right and move to the main floor. At the end of the team performance, the staff will wait for the team to exit the floor and then will be directed to the back exit area curtain (stage left) to collect the team and belongings.

PERFORMANCE FLOOR, MUSIC STATION: The rostered Coach, in charge of music, will be directed to the Music Station at least 10 minutes prior to performance, enter stage right. There will be two stations, Preview and Performance. A Technician will operate the Performance Music Station (Press Play). At the end of the performance, the rostered Coach, in charge of music, will wait for the team to exit the floor and then join the remaining staff to exit area curtain (stage left) to collect the team and belongings.

PERFORMANCE FLOOR: The competition area for the National Championship will be approximately 54' x 42' deep (nine (9) panels). This is a raised platform with entry ramp access and exit stairs.

JUDGES and EVENT SPOTTERS: The Judges' Area will be directly in front of your team during their performance. Competition spotters will be provided for safety.

ATHLETIC TRAINER: An Athletic Trainer will be in the warm-up area and the exit area of the performance floor.

In accordance with and in addition to the Revised Article 17 of the Pop Warner Rulebook, injured athletes may not return to practice/performance without explicit approval from the assigned event medical personnel, but not limited to, Athletic Trainers and/or Emergency Medical Technicians (EMTs).

EXIT AREA: A team will exit the performance area, stage left rear, back of mat/stairs, and wait for the coaches to return from the Coaches' Seating Area. A volunteer will retain the team belongings and each athlete will receive a Gatorade in this area. The team will be directed to the Orange County Convention Center Lobby Area.

MEDIA/INTERVIEW STATIONS: Head Coaches and/or Teams may participate in an interview along with an Entertainment Representative inside the venue. Those interested will participate in a brief interview that may be live on the overhead screen and/or on the event livestream. In order for us to collectively share our stories throughout the event, remember to use the hashtag #PopWarnerCheerandDance and Tag Us @PopWarnerCheerandDance.

ARTICLES OF COMPLIANCE

POP WARNER CHEER AND DANCE NATIONALS

SPECTATOR VIEWING AREA: Fans should arrive ten (10) minutes prior to the team's scheduled performance time at the Performance Floor Spectator Entrance. Fans will be directed into a secured area that will be closed before the team takes the floor. When the team's routine is complete, the fans will be escorted out of the viewing area in time for the next performance. All fans entering this area must show good sportsmanship, respect for the performers and also be aware of the Judges' view. Fans will not be permitted to bring noise makers, megaphones, signs, shakers, etc. into this viewing area. A photographer is on hand to provide action photos of your team. Photographs will be available for purchase at the Orange County Convention Center. Camera, video or any type of recording/photography including cell phones will not be permitted in this Spectator Viewing Area to avoid distraction for the performers and judges.

AWARDS CEREMONY ANNOUNCEMENT: There will be multiple award ceremonies to coincide with current CDC and State/Local requirements. More information to follow.

PARADE OF CHAMPIONS: 1 Coach / 2 Athletes must participate in full uniform and required soft soled athletic wear. The emcee will announce the 1 Coach/ 2 Athletes to enter the Awards Area Stage Left, Photo Opp and Exit Stage Right to designated seating around the perimeter of the Awards' Stage.

NATIONAL AWARDS: The National Cheer and Dance Championships will award **three places, first through third, in each YCADA division**, Show Cheer 1-4, Show Cheer 1 Ltd, Core Cheer 1, Core Cheer 1 Ltd, Sideline Performance Cheer 1, Hip Hop, Theme Dance and Pom Performance. Show Cheer and Sideline Performance Cheer Divisions will be further subdivided by size: Small, Medium and Large. Dance Divisions will apply the natural break when four or more teams are entered into an age division. A championship picture will be taken in the awards area with three (3) awarded teams (First – Third Place).

YCADA GLOBAL BIDS: Pop Warner First Place teams will be awarded Gold bids to YCADA Globals. Pop Warner is proud to support this event which takes place in Atlantic City, New Jersey, February 23-25, 2024.

JAMZ HIGHEST CHEER and DANCE SCORE AWARDS: Cheer/Dance teams with the highest score in their skill division will be announced and awarded Trophy, Championship Rings and YCADA Platinum Bids. (Show Cheer 1-4, Core Cheer 1, Sideline Performance Cheer 1, Pom Performance, Theme Dance, Hip Hop)

ARTICLES OF COMPLIANCE

SCORESHEET DISTRIBUTION: Your score sheet package will be available for pick-up at exit of the Awards' Ceremony. The Head Coach, with picture identification, will be required to sign for score sheets. Only one person per team should come to the pick-area. Pop Warner Little Scholars, Inc. takes no responsibility for score sheets after the championship has ended.

RULES REVIEW STATION: If your team receives a Rules Deduction, the listed Head Coach will receive a text message, approximately 10 minutes following your team's performance, and will be directed to report to the Rules Review Table, next to the Judges' Platform. At that time only, and if you have a Rules Deduction (does not include Point Deductions), the Head Coach with one Assistant Coach may request a brief meeting with the Head Rules Judge for video review to better understand a "listed" rules deduction for their team only.

ELECTRONIC TABULATION PROCEDURES: The Pop Warner National Championships allow each judge to input and assign a point system for Panel Scoring, Point Deduction or Legalities. All equipment and software has been tested and approved for use at the event. If after the Awards' Ceremony a correction is found caused by human tabulation error, the corrections would require a co-sharing of placements to be released immediately online.

PHOTOGRAPHY AREA: This station is located at the Orange County Convention Center. Each team may take a group and/or individual photo(s) in this location at a time during the event that is convenient to your team, remember to check back after your performance for action photos.

NATIONAL CHAMPIONSHIP EVENT SPECIFIC CODE OF CONDUCT: By my signature in the Articles of Understanding Statement of Acceptance, I hereby acknowledge, understand and agree to the following:

- **Proper coaching attire** shall consist of Business, Business Casual or Game Day Attire in the form of a dress, suit, Khaki or dress pants and a polo (with Pop Warner Logo and/or Team/Association/League name and/or logo), or Team Sweat Suit/Athletic Sneakers with Pop Warner Team logo, etc.). The following items are not acceptable: Jeans, shorts, flip flops and/or tank tops. Coaching staff consists of Rostered Staff to include Coordinator, Coaches, Coach Trainee and Student Demonstrators.

ARTICLES OF COMPLIANCE

- **All teams will observe a 10 p.m. Curfew.** As such, all athletes must be in their assigned sleeping rooms by 10:00 p.m. or athletes, coaches and/or the team and association as a whole shall be subject to disciplinary action including but not limited to forfeiture of competition awards, suspension, and removal from Resort property, financial penalties and/or permanent removal from Pop Warner.

However, athletes accompanied by their designated chaperones that are at least 21 years or older who are returning from organized team activities (including without limitation theme park excursions, group dinners, or the Pop Warner Athlete Celebration Party) outside of their hotels shall be excused from such curfew but must be immediately escorted by such chaperones to their rooms upon returning to their hotels. To clarify, for the duration of your stay, all athletes must be in their assigned rooms by 10 P.M. regardless of whether their competition has begun, is ongoing or is completed. Any athletes found outside their assigned rooms past 10:00 p.m. while they are still registered as a Pop Warner group shall be subject to disciplinary action along with their coaches, teams and/or associations as stated above.

- Participants wearing a full medical boot brace/walking boot may not be involved in stunting or tumbling.
- Safety - In concentrated efforts to reduce the risk of injury to athletes, every region/national event will use every possible means to obtain performance mats for safety, as well as to secure professional spotters.

MUSIC POLICY: Ownership and creative rights of music are intellectual property covered by Copyright law. Pop Warner respects the intellectual property rights of others and expects all athletes to adhere to the following rules regarding use of third party music for cheer and dance performance:

- All music used for cheer and dance performance must be purchased from a source authorized to sell a copy.
- You may use a mix purchased from an authorized mix vendor.
- You may use a song in its complete original form, purchased from an authorized vendor (such as iTunes, or a traditional retail store).
- For either a mix or a complete song, save your receipt.
- Regional and National championship performances will be covered by licenses secured by Pop Warner Little Scholars.
- Any recording or broadcast of the cheer / dance event must be done with the music in background / off mic and with a voiceover describing the athletes and the performance.

Super Bowl Articles of Compliance & Manual

- I. Mandatory Team check in must report to the Camping World Stadium.
- II. Team Certification & Book Check will be in the West locker room in the Camping World Stadium. Please have players wear their HOME game jerseys for check-ins. Team Books and player picture ID's must be presented at certification and additional checks will be conducted prior to each game. Please bring Player/Coaches waivers to Certification/Book Check.
- III. Teams must have their books in a presentable and orderly manner ready for inspection at Certification/Check-In. Rosters, ID's, physical forms, parental consent forms will be checked for accuracy and validity. If any paperwork is found to be missing, forged or tampered with the player(s) in question will not be permitted to participate. **We are accepting documents uploaded in the Sports Connect roster software system as well.**
- IV. Please check with your Region Director and/or the Document Audit information on how to organize for book checks.
- V. All players must be listed on the team's Official Certified Roster. Teams must provide absentee forms for any rostered players not in attendance.
 - Pop Warner will provide Mandatory Play Rosters (MPR) via the Roster System for book check.
- VI. MANDATORY Head Coaches Meetings: In order for you and your team to participate in the Super Bowl, each Head Coach MUST attend the appropriate mandatory meeting: both Friday & Saturday & Sunday Meetings will be held at the Varsity Club at Camping World Stadium.

 - League and Association Presidents will be allowed to attend as space permits. If a Head Coach fails to attend, he/she shall not be permitted to coach at the event and may subject his/her team to forfeit(s).

- VII. **Wilson** is the official game ball of the Pop Warner Super Bowl. Balls will be provided at no cost by Pop Warner and MUST be used during Playoff and Championship games. Composite material footballs will be provided.
- VIII. All players shall wear helmets that carry a warning label regarding the risk of injury and a manufacturer's or reconditioner's certification indicating satisfaction of NOCSAE standards. All such reconditioned helmets shall show recertification to indicate satisfaction with the NOCSAE standard. The coach's pregame verification to the referee and another game official that all players are legally equipped and in compliance with the rules includes the exterior warning label.

- IX. All teams must come prepared with two (2) sets of game jerseys (HOME & AWAY), one of which is clearly a light color (AWAY) and the other clearly a dark color (HOME). Teams will be responsible for obtaining proper color jerseys should they fail to bring both. All teams MUST have the Pop Warner Patch displayed on all uniforms in the Pop Warner approved designated areas or may not be permitted to participate.
- X. Proper Coaching attire shall consist of a collared shirt and slacks or Coaching shorts. (Slacks/Shorts color can vary i.e. Khaki, Navy, and Black etc.... Jeans and Cargo pants/shorts are NOT permitted) Collared shirts should have Pop Warner Logo and/or Team/Association/League name and/or logo. (Team jerseys, sleeveless shirts, tank tops, throwback jerseys and the like are not acceptable sideline coaching attire).
- Practice fields will be provided at Emery Hamilton Sports Complex (Fairgrounds) during a majority of the week, and transition back to Camping World Stadium Complex prior to finals days of competition. Teams MUST reserve practice times online at the national championship website. Release days and times will be communicated to head coaches.
 - Practice in any other areas is strictly prohibited. Practice times are limited to 1 practice prior to each game and are strictly non-contact. (Helmets may be worn) If your team cannot make your scheduled practice, you must go online and cancel in advance of your starting practice time or you may forfeit any remaining practices and be charged a \$150 fine for no call no shows. Teams staying at a bus hub hotel will have scheduled transportation to/from practices, all other properties would drive on their own. (*NEW for 2023 – practices will relocate prior to finals back to Camping World Stadium and open up for booking AFTER the semis round of play is completed at 6 PM).

- Study Halls are available in the West Locker Room (adjacent to the Media Room), Camping World Stadium Complex. Study Halls are NOT to be used for watching game film or reviewing plays, they are for academic school work only. You must provide your own transportation or take regularly scheduled Event transportation. The link to reserve time for Study Hall will be released simultaneously with the practice link. Study hall slots are 1 hour in length and are not mandatory – no shows could be subject to a \$150 fine for not showing, as you are taking away a spot from another deserving team.
- Two teams can be accommodated each hour. (*new for 2023 – hours and days have been extended – Mon 10am-2pm, Tues 9am-4pm, Wed 9am-4pm, Thurs 10am-2pm)

As such, all players must be in their assigned sleeping rooms by 10:00 P.M. or players, coaches, the team and/or association shall be subject to disciplinary action including but not limited to forfeiture of past or future game decisions, suspension, removal from partnering property, financial penalties and/or permanent removal from Pop Warner.

- However, participants accompanied by their designated chaperones that are at least 21 years or older who are returning from organized team activities (including without limitation theme park excursions, group dinners, or the Pop Warner Tuesday or Wednesday night Party) outside of their hotels shall be excused from such curfew but MUST be immediately escorted by such chaperones to their rooms upon returning to their hotels. To clarify, when on SeaWorld Orlando or Partner Hotels, ALL participants MUST be in their rooms by 10:00 P.M. regardless of whether their competition has begun, is ongoing or is completed. Any players found outside their assigned rooms past 10:00 P.M. while they are still registered as a Pop Warner group shall be subject to disciplinary action along with their coaches, teams, and/or associations as stated above. Pop Warner National, Regional and Event Staff shall be conducting daily checks to ensure compliance.

XIII. In order to fairly and promptly address any behavior at or associated with the Pop Warner Super Bowl involving any and all violations of the General and Members Codes of Conduct, Pop Warner policy or rules' violations and/or behavior that resulted in harm or may result in probable harm to participants, volunteers, parents, spectators or other individuals, such aforementioned behavior shall be governed by the Disciplinary Review Board (DRB) as outlined in the DRB Policies. All Head Coaches and Association Presidents must read the DRB Policies and sign the attached Statement of Acceptance in order to participate in the Pop Warner Super Bowl. Copies of the DRB Policies are provided under separate cover. Forms requesting a hearing as well as a copy of the DRB process will be available upon request at the Volunteer Room located at the Varsity Club throughout the duration of the Super Bowl.

- As a condition of your team's participation in the Pop Warner Super Bowl, all participants, coaches, administrators and supporters agree to display good sportsmanship throughout the Super Bowl and related events or the entire team's eligibility and presence on site may be revoked without refund. Every Head Coach is required to read and sign the Pop Warner Coaches Code of Conduct at the Coaches meeting to ensure an understanding of what is acceptable conduct for all team and supporters. Head Coaches are responsible for not only their own proper behavior, but also for the behavior of each member of their staff, their team and all of the team's supporters.
- The Head Coach and the Association President will be held accountable for proper conduct of coaches, parents and any other persons affiliated with the team. Head Coaches and Association Presidents must read and review the "Personal Responsibility at PWLS Events and Sportsmanship" memos contained in this packet with your entire team and organization.

XIV. Schedule—All teams are offered and committed to playing 2 games, Sunday and Wednesday, Saturday and Tuesday or Monday and Thursday (14U). All teams are guaranteed 2 games. All Championship games, except for the 14U division, will be played on Friday & Saturday December 8 & 9 . Teams that lose either of their first two games will not play on Championship Friday or Saturday. Teams that choose not to participate in a consolation game, thereby creating a forfeit, will be subject to penalties including but not limited to an automatic one year suspension from Regional and National Championships/Super Bowl for their ENTIRE Association and/or League as well as potential suspensions/removal of the forfeiting team’s entire coaching staff.

XV. In the event of a tie, the ten yard-line overtime procedure will be utilized.

XVI. In accordance with and in addition to the Revised Article 17 of the Pop Warner Rule Book, injured participants may not return to practice/performance without explicit approval from assigned medical personal including, but not limited to, Athletic Trainers and/or Emergency Medical Technicians (EMTs).

XVII. Videotaping Opponents Practice for scouting purposes is forbidden. Violators shall be subject to penalties as outlined herein.

Please come prepared with your own music and radio/box/sound system and speak to the announcer before the start of the game. You must adhere to all Pop Warner rules and procedures.

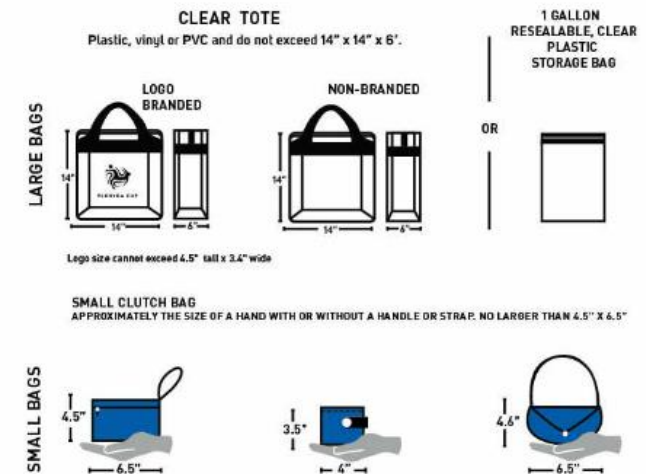

- It is Monday at 12pm after regional qualifiers' weekend, and my team still isn't showing online so that I can begin booking my national package?
 - Your regional director has to send all qualifiers to the national office for approval. Once approved, your team name will show & you may proceed in the proceed booking.
 - 1 unique email is needed for each team
- COVID Safety Guidelines – all procedures can be found on the Pop Warner Super Bowl website link.
- How does the 7-day consecutive SeaWorld and Aquatica pass work?
 - Each person buying the package will be issued a theme park ticket that is valid at both SeaWorld & Aquatica for up to 7 straight days. A photo will be taken at first use, so that ticket is valid only for that individual for the remaining days of that pass.
- Curfews – All Pop Warner participants must adhere to a 10:00pm curfew in accordance with the signed code of conduct.
- What if I have a room in my team's block that needs an ADA access room?
 - Please give our hotel team a heads up during the booking process by typing notes into your request & be as specific as possible so we can make your arrival as seamless as possible.

- What does security look like at facilities?
 - A designated athlete/coach entrance will be designated at both competition venues to accommodate bags needed specifically for our competitors.
 - ***NEW FOR 2023** – just like most sporting events across the country, we are instituting a clear bag policy for both competition venues. Safety first!
 - Fans will be able to carry the following style and size bag, package or container in addition to regular items such as phones, chairs, etc.:
 - ✓ Bags that are clear plastic, vinyl or PVC and do not exceed 14" x 14" x 6" (pictured here)
 - ✓ One-gallon clear plastic freezer bag (Ziplog bag or similar)
 - ✓ Diapers can be carried in permissible 12" x 6" x 12" clear bags
 - ✓ Small clutch bags that do not exceed 4.5" x 6.5" (pictured here) can be taken into competition venues in addition to one of the clear plastic bags
 - ✓ An exception will be made for medically necessary items after proper inspection at a gate designated for this purpose

- Where can I find a full list of prohibited items at the competition venues?
 - The official Pop Warner website has a complete list of FAQs available for both Camping World Stadium & the Orange County Convention Center.
- How will transportation included in the package work during our stay?
 - If your team has indicated in the booking process that you will be using event transportation during your stay in Orlando, event buses will be labeled & available for all days & hours of competition to event venues (football to Camping World Stadium & cheer and dance to Orange County Convention Center North Hall). **ALL ATHLETES & COACHES WILL NEED TO WEAR THEIR CREDENTIALS, AND PARENTS WILL NEED TO SHOW THEIR VENUE TICKETS TO BOARD THE BUSES.**
 - Buses will also be running to SeaWorld & Aquatica theme parks on a continuous schedule – refer to the Pop Warner website for all Super Bowl specific details.
 - In addition, buses will run for the Pop Warner Celebration Party to SeaWorld on Tuesday night, December 5th & Wednesday night, December 6th from 7pm-12:30am (reference your ticket for your specific night booked during the initial booking process).
 - **BUS TRANSPORT TO/FROM THE AIRPORT IS NOT INCLUDED IN THE PACKAGE**

- **What if my team wants to use a hotel meeting room and/or have a team meal?**
 - **Contact information for the sales managers at each hotel are included in this manual on pages 77-79 – many hotels have convention center space available but please inquire about availability & any required food or beverage requirements (if any)**
- **What if my team is going to the Pop Warner Celebration Party on Tuesday night but my family wants to attend on Wednesday instead?**
 - **Due to capacity and the complexity of scheduling, all participants on a team are required to choose the night they collectively would like to attend during the initial booking process (so no splitting up groups).**
- **What if I miss going to the special Pop Warner Celebration Party at SeaWorld on Tuesday....can I attend on Wednesday instead?**
 - **Unfortunately, no – tickets are coded for a specific night based on capacity restrictions and all tickets have already been accounted for. If you arrive on Wednesday, the tickets will not work to gain admission.**
