Application for Financial Aid

Bellevue Soccer Club (BSC) offers financial aid to eligible and deserving families that meet certain household size and income criteria. Financial aid applies to registration fees only. BSC does not offer assistance for other expenses, including uniform, coaching fees, tournaments, or team fees. BSC uses the State of Nebraska's income guidelines for Nutrition Services to determine eligibility for financial aid. BSC reserves the rights to adjust the discount amount(s) if necessary due to demand.

Application Process:

1. Complete this form with appropriate player and parental information.
2. Financial aid can be requested for multiple children in the same household; however separate applications are required for each player.
3. Provide verification of income and household size.
 - a. BSC will accept the current school letter approving free or reduced lunch; or
 - b. Provide the most recent Federal or State income tax return – main forms only (1040).
 - c. BSC does not keep any submitted financial records – all files are shredded after confirming eligibility.
4. If unable to submit application prior to registration deadline; submit with Registration
 - a. Players will have to pay full registration amount.
 - b. BSC will send a refund of the registration fees (Rec players) within 30 days if approved.
5. All information is strictly confidential and used for the sole purpose of helping BSC verify income eligibility.
6. Incomplete forms will not be considered and requests are considered on a case-by-case basis.
7. Financial Aid is approved for a single session/season only and must be re-applied for in subsequent sessions/seasons.
8. Approved Financial Aid cannot be combined with any scholarship; applicant/family must decide which monetary aid they wish to accept.

10. Players/family will receive notification of approval/disapproval within 14 days of application submission.

Volunteer hours are determined by player registration.

Families that do not complete the required amount of volunteer hours during the season, will be denied financial aid in the future.
