

## FINANCIAL COMMITMENT

Below are the financial commitments you will be asked to provide during the season:

<u>Opening Day Raffle Tickets:</u> On Opening Day, we will be raffling off prizes. Tickets are \$5.00 each. Each player will be issued 6 tickets to sell for a total of \$30. Additional raffle tickets will be available for sale if needed.

**Basket Silent Auction:** Each player will need to donate \$20 to the team's Opening Day Basket Silent Auction. The Silent Basket Auction donations will be collected by Team Mom. Each team's basket should have a theme. The funds from the auction will go directly to improving our little league and to provide items teams need.

<u>Snack Bar Deposit:</u> Each player MUST submit **TWO (2)** \$100.00 checks as a deposit for their snack bar shift. The deposit will be returned upon completion of the shift. If you do not show up for your shift the check will be cashed.

<u>World's Finest Chocolate Fundraiser</u>: Each player will receive **TWO (2)** boxes of chocolate bars (which include a variety of flavors). Each chocolate bar is \$1.00 each box contains 60 chocolate bars. 62% of World's Finest Chocolate Fundraiser profit will go directly to the league. Prizes will be awarded for the top seller overall and a prize for the top seller in each division (T-Ball, Minor C, Minor B, Minor A, Majors and Juniors). **Participation is MANDATORY.** 

<u>World's Finest Chocolate Fundraiser – Opt-Out Option</u>: If the player chooses NOT to participate in the World's Finest Chocolate Fundraiser **the opt-out option** is available. Parents may submit a check payable to Crescent Little League in the amount of \$120 (please make sure to write the players name, Division and team name on the re line of the check).

**Sponsorship:** Each team is required to acquire a sponsorship with a minimum amount of \$350. This can be split between several businesses or individuals.

**Team Costs:** Each team has the option to purchase a banner for their team, which costs usually around \$12 per player. Also, teams have the option to purchase practice shirts with each player being responsible for their own. Each player is **required** to purchase their own socks, pants and belts as needed. The league will provide jerseys and hat to all divisions.

## **Fundraising and Refund Policy**

It is the objective of Crescent Little League (CLL) to provide children with a wholesome atmosphere in which to engage in healthy athletic competition. We encourage cheering, excitement, and exuberance; however, your enthusiasm must be expressed in a positive manner.

- We will not tolerate any behavior on the playing field or in the stands, which would hinder the spirit of encouraging sportsmanship and cooperation.
- At no time will we permit abusive language or profanity, directed at or in the vicinity of the players, coaches, managers and/or the umpires.
- No alcoholic beverages or person/s under the influence of alcohol will be permitted on the CLL premises or on any other game, field or school property.
- NO SMOKING OR VAPING IS ALLOWED on the athletic field or within 500 feet of the dugout areas.
   Smoking must be contained to the sidewalk area, as there is no smoking allowed on school property.
- Do your part to keep our facility clean, pick up your trash before leaving the facility.
- NO DOGS ARE ALLOWED ON THE BASEBALL FIELDS or on the premises.

REPEAT OFFENSES COULD RESULT IN EXPULSION FROM THE LEAGUE.

This is a volunteer program. Failure to comply with these rules may result in a player, parent, family member and/or guest, being asked to leave the premises and/or could result in the forfeiture of the game.
